Captain Lazar's Message

I would like to start this week's newsletter by mentioning a home invasion robbery which occurred on the boarder of Chinatown on Easter Sunday. The suspect entered senior housing and tried every door until he found a door unlocked. He entered a 92 year old woman's unit and began going through her cabinets. When she exited the bathroom, the suspect ripped her wallet out of her pocket and fled the building. Thanks to our partnership with the Chinatown Community Development Center, we were able to obtain the video of the suspect in the building.

Several of us at the station, including the Station Investigation's Team and the Plainclothes team viewed the video. **Inspector Lee** immediately recognized the suspect as did **Officer Ciudad** from the Plainclothes Team. **Officers Ciudad, Huang and Reyes** left the station and went through Chinatown, then onto Market Street where they captured the suspect at Market and Cyril Magnin within an hour of watching the video. The suspect was wearing the same clothing he was wearing when he committed the crime. He was booked for Robbery, Burglary, Violation of Parole and Violation of Probation. This is a great win for the community and for Central Station!

I have reflected on this great case and I would like to share my thoughts:

1. Our partnership and collaboration with the community, which in this case includes the Chinatown Community Development Center, is essential to solving crimes.
2. Having surveillance cameras installed on residential and commercial properties are an important element to solving crime in 2015. This case was solved quickly because video equipment was installed in this particular building.
3. The suspect was able to enter the building by following someone in. Those who live in multi-unit buildings must be mindful to not let anyone they do not know follow them in. If a person feels intimidated, they should immediately phone the police.
4. If a person lives in a multi-unit building, even if they feel comfortable with their neighbors, should still lock their unit regardless if they are home.
5. If a person believes something or someone is suspicious, they should go with their instinct and phone the police.

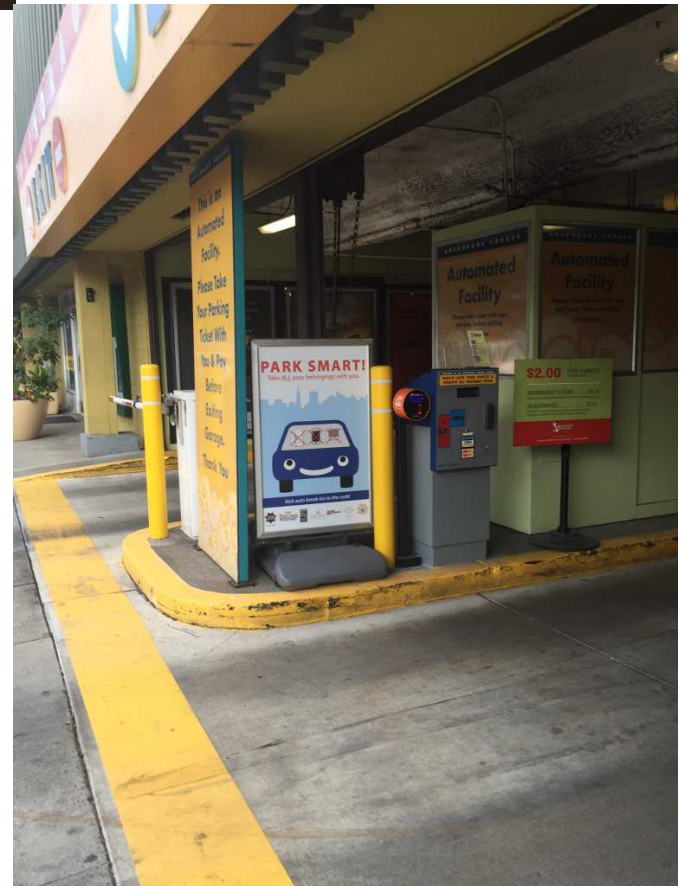

Crimes of Note

Definitions

Robbery – Robbery is the taking of property from another by using force or by using fear.

Assault – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery - (Misdemeanor battery) is any willful and unlawful touching of another.
(Felony battery) is the use of force or violence upon the person of another that causes serious bodily injury.

***Assault is when a person wings their arm and battery is when that arm makes contact with another person.**

Aggravated Assault – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

Burglary – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

Grant Theft – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

Petty Theft – Theft where the value of the property taken is less than \$950.

San Francisco Police Arrest Suspect in China Town Home Invasion, Robbery

On April 5, 2015 at 4:00 PM, the victim, a 92 year old female was in her apartment on the 700 block of Broadway when the suspect entered through the front door. The victim walked into her living room and found the suspect rummaging through drawers. Upon seeing the victim, the suspect walked up to the victim and grabbed her wallet which was located in her shirt pocket. The victim attempted to grab her wallet in an effort to prevent the suspect from taking it. The suspect tore the pocket, and pulled the shirt off of the victim before fleeing with the wallet. The victim was not injured.

Officers from Central Police Station responded and began an investigation. The investigation revealed surveillance camera video which was later found to have captured images of the suspect. Investigators reviewing the video recognized the suspect from past police contacts. On April 7th, members of the Central Station Plain Clothes Unit viewed the video, recognized the suspect and set out to locate him. Later that evening, the Officers located the suspect at Market Street and Cyril Magnin, still wearing the same clothes that he was wearing during the incident.

The suspect was taken into custody without incident and later booked into County Jail.

Fred Jones, 46, San Francisco was booked on felony charges of: Burglary in the First Degree, Robbery, Elder Abuse and for violating his Parole and Probation. A booking photo accompanies this press release.
