### Two Common Thefts

I have mentioned both of these items in previous newsletters.

First, over the last few months, we have seen a steady reporting of bicycles stolen out of garages. Although not limited to single family dwellings, most of the thefts occur where there are common garages in flats or apartment buildings. If you lock your bicycle up in you building's garage, please ensure you are taking all of the necessary steps to safeguard your bicycle. In addition to registering your bicycle (sfsafe.org), taking photographs of it, recording the serial number and most importantly, properly locking the bicycle is essential. Bicycle thieves are using whatever means possible from bolt cutters to battery powered cutting instruments to get through the locks. Please keep this in mind.

The second, as mentioned in a previous newsletter, is package thefts. Although I have already covered this topic, I read a disappointing report of an incident which occurred yesterday at 3:45 p.m. in the Central District. The resident was home and expecting a package containing her running shoes from UPS. She heard the UPS truck and saw it driving away. She went to the door just in time to see the suspect holding her package. He saw her and took off running, with her shoes. This is something for everyone to keep in mind, even if you are home and ready to receive your package.

**Auto Burglaries**

At every opportunity, I will speak with the community about preventing becoming a victim of an auto burglary. The amount of car break ins are up from this time last year. This has been one of my primary issues since arriving at Central Station.

As we got into our car, I was informed by my family that the car parked behind us had a sign on the passenger side which read "there is nothing in this vehicle" and then had an SFPD Logo. I wonder if this works? More importantly, maybe this is something all of us should place in our windows or maybe a rental car agency can give these signs to tourist when they rent a vehicle. Something I am thinking about today.

## Crimes of Note

### Definitions

**Robbery** – Robbery is the taking of property from another by using force or by using fear.

**Assault** – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

**Battery - (Misdemeanor battery)** is any willful and unlawful touching of another.  
**(Felony battery)** is the use of force or violence upon the person of another that causes serious bodily injury.

**\*Assault is when a person swings their arm and battery is when that arm makes contact with another person.**

**Aggravated Assault** – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

**Burglary** – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

**Grant Theft** – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

**Petty Theft** – Theft where the value of the property taken is less than \$950.
