## Crimes of Note

### Definitions

Robbery – Robbery is the taking of property from another by using force or by using fear.

Assault – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery - (Misdemeanor battery) is any willful and unlawful touching of another.  
(Felony battery) is the use of force or violence upon the person of another that causes serious bodily injury.

\*Assault is when a person swings their arm and battery is when that arm makes contact with another person.

Aggravated Assault – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

Burglary – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

Grand Theft – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

Petty Theft – Theft where the value of the property taken is less than \$950.

### **San Francisco Police Identify Two Suspects in “Blessing Scam”**

Investigators from the San Francisco Police Department’s Special Victims Unit have released the identity of two suspects wanted in connection with the “Blessing Scam” that has occurred in the Chinese community. The “Blessing Scam” is an ongoing series of scams targeting older Chinese victims, resulting in great financial loss.

The scam often occurs after the victim is approached by the first of three female Cantonese-speaking suspects. The suspect asks the victim if she knows a doctor in the area because a family member had fallen severely ill. The second suspect joins the conversation stating that she knows a doctor, and persuades the victim to all visit this doctor together.

While en-route to the doctor, an additional suspect approaches the group and acts as a fortune teller. This fortune teller tells the victim a loved one will be cursed or suffer some form of misfortune. To relieve the curse, the victim must present the fortune teller with valuables to be “blessed.”

The suspects convince the victim to bring valuables, consisting of currency and jewelry to a nearby street. A “blessing” is performed. Then, through sleight of hand, another bag containing worthless items was given back to the victim. The victim is instructed not to look in the bag for a specified amount of time or the “blessing” would be invalidated.

San Francisco Police are investigating four incidents reported thus far in 2016. The first reported case was in the Richmond District in July 2016, followed by two in the Central District August 5th, and August 8th and a final reported case in the Richmond District August 9th.

The Special Victim's Fraud Unit has vigorously investigated all four cases. Today we, the San Francisco Police Department are happy to announce that we have identified two suspects in a blessing scam that was committed here in San Francisco.

Warrants have been issued for the arrest of: Yiyuan Li, age 57 and Jinqin Zhen, age 48 on the charges of theft from elder, grand theft of property and conspiracy. We believe that these two suspects conspired with two others to commit a blessing scam in the Richmond District. Yiyuan Li is also a suspect in a similar case in New York and she is also has an arrest warrant in connection with the New York investigation. We will continue to work and collaborate with New York City Police, the District Attorney's Office and Homeland Security to ensure the arrest of these outstanding suspects.

The Special Victim's Fraud Unit of the SFPD will continue to work these cases in an effort to find justice for these victims. The San Francisco Police encourage anyone who has been a victim this crime and has not already reported it to please report it now. We cannot express how important it is that you do this so that we can work to bring these predators to justice. Members of the community can help stop this crime by keeping a close eye on their elders and talking to them about this scam.

If you are a victim of the scam please report it. If you have any suspicions that you maybe witnessing or have witnessed the scam please call the police. ### Shooting at Aquatic Park-San Francisco

**SAN FRANCISCO** – The United States Park Police is investigating a fatal shooting that occurred shortly before 10 pm on Saturday, August 6, 2016 at Aquatic Park in San Francisco, California. Calvin Riley, a 20 year-old male from San Mateo, California was tragically killed while walking along the promenade near Van Ness Ave.

The United States Park Police is requesting assistance from the public in identifying a 2013-2015 white 4-door Toyota Avalon that was observed leaving from the scene shortly after the shooting. Two individuals associated with this vehicle are believed to be an African American male and a Caucasian female. ## Our History

San Francisco SAFE, Inc. (Safety Awareness for Everyone) is a community crime prevention and public safety program that works in cooperation with the San Francisco Police Department and other city agencies to help San Franciscans protect themselves from becoming victims. SAFE was created in 1976 as a project of the SFPD. In 1980, SAFE became a non-profit 501(c)(3) corporation, and 30 years later, continues to act as the crime prevention component of the police department. A major portion of SAFE's income comes from a grant contract with the SFPD, but SAFE also receives donations and grants in order to expand and enhance our crime prevention and public safety services. SAFE has also received numerous grant awards from the City and County of San Francisco, the San Francisco Mayor's Office, State Office of Criminal Justice Planning and local foundations. We have provided major support to the San Francisco Police Department and Mayor's Office by acting as a fiscal agent for these federal and state funded grants, along with participating in numerous crime prevention activities as a part of these grants.

## WHAT IS SAFE BIKES

If a bicycle is stolen, even if it is recovered, it is almost impossible to find the owner. Until now. SAFE Bikes is a community collaboration to help reduce bike theft in San Francisco and support bike owners getting their bikes back in the event that their bike is stolen. We have created a bicycle registry to help you get your bike back and to prove that the bike is yours. If your bike is recovered, officers can look up your serial number or registration tag number to return the bike to you. SAFE Bikes also hosts educational workshops and provides valuable information to help you lower the likelihood of your bike getting stolen.



## IF YOUR BICYCLE IS STOLEN

- **STEP 1.** Go to your local police district station in San Francisco to file a police report, in person, online, or call 415-553-0123.
- **STEP 2.** Follow the steps listed here to increase your chances of getting your bicycle returned.
- **STEP 3.** Check the Stolen Bike Registry and Bike Index for your stolen bicycle.



### LOCKING TECHNIQUE


- **STEP 1.** Secure rear wheel with small, hardened steel U-lock inside the rear triangle
- **STEP 2.** Make sure U-lock is secured to an immovable object
- **STEP 3.** Secondary metal lock (cable or another U-lock) placed on front wheel
- **STEP 4.** Replace quick release skewers with keyed locking skewers to ensure wheels and saddles are locked to frame.

This is only one of many locking methods. None are 100% guarantee

### What is the ALERT Program?

The San Francisco Police Department has developed a volunteer citizen disaster preparedness program. The Auxiliary Law Enforcement Response Team (ALERT) is modeled after and works in partnership with the San Francisco Fire Department's Neighborhood Emergency Response Team (NERT). The ALERT program will train members of the public to assist law enforcement in essential tasks after a major disaster. Such tasks may include: traffic control, foot patrol of business and residential areas, and reporting criminal activity. Volunteers must be at least 16 years of age and live, work, or attend high school in San Francisco.

#### Three steps to becoming an ALERT volunteer:




