All recognized that adding new equipment to already overburdened wooden poles would further mar our public vistas; this particular installation would greatly diminish the view of Alcatraz from tourist rich Leavenworth Street. The Board determined that it would be more appropriate for the adjacent homeowner to file the appeal. Doing so would also allow more individual Board members to testify at the future hearing under public comment, than could testify during the limited appellant's time. The Board pledged to continue its opposition to such installations, and to encourage Board and general RHN members to testify at the
