Northern Police Station Projects: ADA Barrier Removal Project & Renovation Project

ESER 2014

The Northern Police Station construction projects are funded by the Earthquake Safety and Emergency Response (ESER) Bond which passed in June 2014. The general obligation bond authorized \$30 million for upgrading district police stations and infrastructure. To date, 2 ADA Barrier removal projects are completed and 5 additional projects are slated for construction this fall.

The ADA Barrier Removal Project at Northern Police Station scheduled for construction this Fall includes ADA improvements including accessible path of travel on the sidewalk and entry, accessible counter, phone and signage.

The Renovation Project at Northern Police Station slated for construction in the Spring of 2017 includes voluntary structural strengthening, roof replacement and mechanical, electrical and plumbing (MEP) upgrades.

****The officers of Northern Station work hard each and every day to keep the streets safe for everyone. They are making some excellent arrests. Here is a **small snapshot** of what they are doing. I encourage you to log on to the SFPD website and under 'compstat' you will find a link to 'crime maps' that will provide very timely crime information and a greater accounting.**

Burglary, Vehicle, Warrant Arrest, Golden Gate/Franklin, 8-3-16 0200hrs

Officers were in full uniform and driving a marked police vehicle when they responded to the intersection of Golden Gate and Franklin Street regarding a vehicle that was broken into. The 911 caller provided a description of the suspect as a black male wearing a red sweatshirt, blue jeans, approximately 45 years old. When the officers arrived they made contact with the 911 caller and spotted the subject who matched the description. The officers stopped and detained the suspect. The 911 caller told the officers that he parked and locked his vehicle and went into his house. A few hours later he went back out to his vehicle to get something and saw the suspect standing by his car. The 911 caller saw the left side passenger window was shattered. The 911 caller yelled at the suspect and called the police. The officers did a computer check on the suspect which revealed

he had an outstanding warrant for his arrest for burglary. The officers took custody of the suspect and placed him under arrest. The officers searched the suspect and located a silver bracelet in his pants pocket. The victim positively identified the bracelet as being his friends who left it in the boosted vehicle. The officers finished their investigation on the street and transported the suspect to Northern Station. At Northern Station the officers confirmed the warrant and booked the evidence. The officers completed a police report. The suspect was later transported to County Jail and booked accordingly.

Assault, Aggravated on Police Officer, Fillmore/O'Farrell, 8-7-16, 2330hrs

Officers responded to the 1500 block of Fillmore Street on a report of a citizen holding a prisoner. Dispatch informed the officers that a suspect just burglarized a locker room of a restaurant. An off duty officer who was at the restaurant was following the suspect while he was on the phone with 911. Several officers responded to the scene and stopped and detained the suspect. The off duty officer told the other officers that he has friends who work at the restaurant. They told him that someone entered the locker area and was going through the employees lockers. The off duty officer approached the suspect and told him he was an off duty San Francisco Police Officer. The suspect picked up his bags and left the restaurant. The off duty officer told the suspect to stop several times but he refused to comply with his verbal commands. The suspect punched the off duty officer in the face. The suspect then pulled out a large pair of bolt cutters and tried to swing it at the off duty officers head. The officer backed off and followed the suspect until police arrived. The off duty officer pointed the suspect out the responding officers and they took him into custody without further incident. The officers conducted a thorough investigation and recovered several stolen items from the suspect's person. A computer check revealed the suspect was on felony probation for grand theft. The items recovered were returned to the owners. Photos were taken at the scene. The officers transported the suspect to Northern Station to be interviewed. The suspect refused and he was later transported to County Jail where he was booked accordingly.

Burglary, Vehicle, Haight/Octavia, 8-14-16 1710hrs

An officer was in full uniform and riding an SFPD bicycle in the above area when he was flagged down by a citizen who told him that someone just broke into her car. The citizen was pointing down the street and told the officer the suspect was wearing all black clothing and took her black backpack out of her car. The officer continued to ride his bike in the direction the citizen last saw the suspect. The officer immediately spotted the suspect who matched the description and who was also the only other person riding a bicycle in the area. The officer caught up with the suspect and ordered him to stop. The suspect complied without further incident. Additional officers arrived on scene to assist. The officer did a computer check on the suspect and learned he was on probation and had a search condition. The suspect was carrying two black backpacks. The backpack contained a MacBook Pro laptop computer. The officers located the owner of the vehicle who positively identified the backpack and the computer as being his. The officers returned the items to the owner and gave him the proper paperwork. The officers took photos and completed their investigation at the scene. The suspect was transported to County Jail where he was booked accordingly.

Warrant Arrest, Fern/Polk, 8-24-16 1920hrs

Officers were in full uniform and driving a marked police vehicle. They were patrolling in the above area when they observed a female subject laying on the sidewalk on Fern Street. The female subject had her belongings scattered all around her, which prevented pedestrian from walking on the sidewalk. The officers recognized the subject from prior contacts and believed she could possibly have an outstanding warrant for her arrest. The

officers stopped and detained the subject and did a computer check on her. The computer revealed she had an outstanding warrant for her arrest for assault. The officers confirmed the subjects identify through her mugshot and informed her of the warrant. When the officers tried to take her into custody she began to fight with them by pulling her arm away, trying to bite them, and constantly kicking them. The officers gained control by taking her to the ground and placing her into handcuffs. The officers called for our wagon to respond due to her violent behavior. The suspect was banging her head against the walls and seat of the wagon. The officers saw the subject was speaking incoherently and called for an ambulance to respond. The ambulance along with the officers transported her to SF General Hospital. After the suspect was medically cleared by the doctors the officers transported her to County Jail where she was booked on her warrant.

Firearm, Carrying loaded with intent to commit felony, 8-28-16 600 Larch Way 0017hrs

Officers were in full uniform and patrolling the area when they were dispatched to the above area regarding a person knocking on a door. The 911 caller stated the person knocking on her door was her son and she was in fear for her life. She informed our dispatcher that her son is on Parole and may be on drugs and may have a weapon. When the officers arrived they spotted a male who matched the description that dispatch gave. The officers stopped and detained the subject. The subject was not cooperative. The officers told the suspect to put his hands on his head which he refused. When the officer grabbed the suspect's hands the suspect began to fight with the officers. The suspect pushed and grabbed at the officers waist. The officer feared that the suspect may have a weapon and attempted to grab the suspect's hands to prevent him from grabbing something out of his waistband. The officers called for additional units to respond. The first two officers continued to fight with the suspect until other officers arrived on scene and put the suspect into handcuffs. While the suspect was lying on the ground an officers saw a handle of a firearm sticking out of the suspects left rear pants pocket. **The officers seized a Smith and Wesson .380 handgun**, which had a magazine inserted. During an arrest search the officers seized two baggies of suspected methamphetamine and two .380 bullets wrapped in black cloth from the suspects pants pocket. Marijuana and a scale was also seized from the suspect's jacket pocket. The suspect was transported to Northern Station for further investigation. After a thorough investigation at the scene the officers interviewed the suspect. All the evidence was booked and the suspect was later transported to County Jail where he was booked on multiple charges.

Firearm, discharging at an Inhabited Dwelling, 1700 blk Green St, 8-29-16 1839hrs

Officers were dispatched to the above area regarding a man with a gun. The 911 caller stated that her friend was having a psychotic break down, and grabbed a gun. The 911 caller ran out of the house and then heard gunshots. The officers cautiously approached the house and knocked on the door. The suspect opened the door and the officers detained him without incident. The officers searched the house for other suspects but there was no one else in the house. In plain view of the officers they saw multiple handguns, 35 cartridges inside magazines and an assault rifle. The officers also observed four holes in a wood panel wall in the kitchen. The holes appeared to be bullet holes. The officers met with the 911 caller who told them that the suspect has been acting strange lately and has been having psychiatric issues. While she was running out of the house that is when she heard the gun shots. The officers spoke to the suspect who was sweating, shaking and looking around. The officers believed that the suspect was on some type of narcotic due to his behavior and the narcotics paraphernalia that was located in his home. The officers took custody of the suspect and transported him to SFGH PES. The officers seized several handguns, rifles, and ammunition from the home and booked it into evidence. **Over 50 Firearms were seized.** After the suspect was cleared from SFGH he was later booked at County Jail.

Warrant Arrest, O'Farrell/Larkin, 9-6-16 2206hrs

Officers were in full uniform and patrolling the area when they spotted a male riding his bicycle on the sidewalk. The officers stopped and detained the male for the violation. The officers did a computer check on the male and learned that he had an outstanding warrant out for his arrest for Domestic Violence. The officers took custody on the male and conducted an arrest search. During the search an officer located off white rock substance in the suspects pants pocket. The officers believed this to be suspected crystalized methamphetamine. The officers completed their investigation at the scene and transported the suspect to Northern station. At Northern Station the officers tested the narcotics with a narcotics kit which came back positive for Methamphetamine. After a thorough investigation the suspect was later transported to County Jail and booked accordingly.

Burglary, Non Residential, 1500 Blk Eddy Street, 9-6-16 2250hrs

Officers were in full uniform in the area when they responded to the 1500 block of Eddy regarding a burglary/petty theft suspect who was in the parking garage. The 911 caller who is a security guard told the officers that the suspect that was in the parking lot was the suspect from an incident that occurred the day before where he stole keys and broke into a vehicle. Several officers searched the parking garage where multiple vehicles were parked. One of the officers spotted and recognized the suspect from prior contacts and arrests. That officer also had knowledge through a photograph crime bulletin from a prior burglary that the suspect also matched that description. The officers took custody of the suspect without further incident. The officers searched the suspect and located several keys and a key FOB in the suspect's pants pocket. The officers took photos of the evidence and the scene and transported the suspect to Northern Station. The security guard informed the officers that he had the suspect on video surveillance. After a thorough investigation the suspect was later transported to County Jail and booked accordingly.

Burglary, Vehicle, McAllister/Steiner 9-10-16 1130hrs

Officers were on uniform patrol when they were dispatched to Steiner and McAllister regarding an auto boost that just occurred. Dispatch described the suspect as a white male, about 6 feet tall, carrying a cane and wearing a red/white beanie. Several officers responded and immediately searched the area. Within minutes the officers located the suspect who matched the description that dispatch gave and detained him. The officers located the 911 caller who told them he was circling the block looking for parking when he saw the suspect break the window to the victim vehicle. The 911 caller watched the suspect as he rummaged through the vehicle and take items out. The 911 caller positively identified the suspect as the one who broke the window of the vehicle and took items out. Officers took photos the scene and located the owner of the vehicle. The suspect was transported to Northern Station for further investigation. A records check revealed the suspect had an outstanding warrant for his arrest for fraud. The suspect was later transported to County Jail and booked accordingly.

Domestic Violence Information

The San Francisco Police Department's Special Victims Unit (SVU) is a centralized police investigative unit located at the Hall of Justice- 850 Bryant Street, Room # 500. A staff of inspectors at the SVU reviews 350 to 400 incident reports of domestic violence each month.

The SVU investigates all felony arrest cases involving abuse committed against any person, who is a spouse, former spouse, cohabitant, former cohabitant, in a current or former dating relationship, in a current or former engagement, or have a child in common. This includes boyfriend/girlfriend and same sex relationships. The SVU also investigates elder abuse cases (neglect and physical) and stalking cases.

All non-arrest reports are also reviewed by the SVU. The SVU Inspectors telephone every victim in an attempt to advise her/him about follow-up procedures and referrals. A message is left if voice mail is available. **It is important to note that attempts are made to contact all victims in every domestic violence, elder abuse and/or stalking case. Likewise, no SFPD domestic violence report is "just filed". All reports are reviewed; computer checks on alleged suspects for parole/probation violations are completed; victim notifications are conducted and the results of all of the work are logged.** The SVU works closely with Victim Services, Adult Protective Services, and Safe Start I. If you are a victim or know someone who is a victim of domestic violence, please contact the SFPD's Special Victims Unit at 415.553.9227. In an emergency, dial 911. Please be safe and remember that reporting domestic

violence doesn't just assist the victim but the victim's family as well.

Text-a-Tip Set Up Instructions

Non-Blackberry Cellular Telephones: Dial 847411-then **SAVE** this to your phone contacts as a mobile number. Name this new contact **TIP411**. Now the number is ready to be used to send text messages. When sending a message, **type SFPD then leave a space**. Type your **Message** and **Send**. You will receive a reply message in seconds.

Blackberry telephones: Similar to above. First you need to add TIP411 to your mobile contact list. Select TIP411 enter. The cursor will be in blue on the #8 (847411). Click the ball and select **SMS TEXT TIP411**. Type your message starting with **SFPD (space) ... then send**. You will receive a response within seconds.

EARTHQUAKE SAFETY TIPS

During the Earthquake:

- If you are indoors, stay there. Quickly move to a safe location in the room such as under a strong desk, a strong table, or along an interior wall. The goal is to protect you from falling objects and be located near the structural strong points of the room. Avoid taking cover near windows, large mirrors, hanging objects, heavy furniture, heavy appliances or fireplaces.
- If you are cooking, turn off the stove and take cover.
- If you are outdoors, move to an open area where falling objects are unlikely to strike you. Move away from buildings, power lines and trees.
- If you are driving, slow down smoothly and stop on the side of the road. Avoid stopping on or under bridges and overpasses, or under power lines, trees and large signs. Stay in your car.

After the Earthquake:

- Check for injuries if needed, help ensure the safety of people around you.
- Check for damage. If your building is badly damaged you should leave it until it has been inspected by a safety professional.
- If you smell or hear a gas leak, get everyone outside and open windows and doors. If you can do it safely, turn off the gas at the meter. Report the leak to the Gas Company and Fire Department. Do not use any electrical appliances because a tiny spark could ignite the gas.
- If the power is out, unplug major appliances to prevent possible damage when the power is turned back on. If you see sparks, frayed wires, or smell hot insulation turn off electricity at the main fuse box or breaker. If you will have to step in water to turn off the electricity you should call a professional to turn it off for you.

311 Customer Service Center:

What is 311? 311 is a toll free, **NON-EMERGENCY** phone number that the public can call to access information about government services. A live customer service representative will be available 24 hours a day, seven days a week, and 365 days a year. The service is available to both wired and wireless customers. Wireless customers should call (415) 701-2311. 311 employees will be able to provide translations services in more than 145 languages and dialects and will employ a diverse staff of customer service representatives. Once your complaint is logged you will be given a tracking number to follow up on at a later date. Additionally, 311 are set up to accept calls from the hearing impaired by utilizing a TTY System. **Note:** 3-1-1 now has a victim's services website: <http://sfvictimservices.org> for more information.

How does 911 work on cell phones in San Francisco?

If you are on **surface streets** in San Francisco and dial 911, your call will be answered by the San Francisco Department of Emergency Management. Once the San Francisco Department of Emergency Management determines what emergency services are needed, they will then process your call.

If you are on a **freeway** in San Francisco and dial 911, your call will be answered by either by the San Francisco Department of Emergency Management Services or the California Highway Patrol Dispatch Center. Regardless, your 911 call will be routed to the proper emergency agency, the San Francisco Police Department, the California Highway Patrol, or the San Francisco Fire Department, including ambulance service.

District Supervisors
